SCOPE

To manage the quality of the Supply Chain from the receipt of externally provided product/services, supporting and directing the management of supplier performance (quality and on-time delivery), the timely processing of product/services through Receiving Inspection, the control and processing of suspect non-conforming materials, the coordination and communication with Supply Chain (Procurement/Suppliers), Integrated Product Teams (IPTs), Manufacturing (including In-Process Inspection), Production Planning, and assigned resources, while supporting the timely demand and quality needs of the organization. Reporting supplier performance to executive management and integrating with the supply chain management organization.

RESPONSIBILITIES

Directs the organization's plans, goals and personnel to ensure the following:

Effective Supplier Management:

- Manage and implement a Supplier Quality Management System that ensures parts received meet Marvin Engineering's purchase order and customer contractual flow down requirements in a cost-effective manner.
- Establish and maintain system and procedures that will enhance the overall quality of the supplier chain.
- Manage supplier performance through the use of approved supplier lists, SCARs and evaluations in accordance with applicable procedures.
- Analyze supplier performance data and maintain supplier scorecards.
- Facilitate the development of team or supplier partnering relationships for long-term contracts.
- Ensure source inspection activities are executed efficiently and effectively.
- Escalates all issues to a higher level of management when no response or support is provided.

Effective Quality Verification:

- Manage Quality Control processes to ensure effective verification of supplier provided goods and services.
- Set expectations related to functional priorities and ensure that daily inputs/outputs goals are met.
- Support QC management in the achievement of QC goals and continual improvement objectives.
- Ensure Quality Control inspection practices and methods are based on industry best practices and that personnel are qualified to implement methods (including use of equipment). This is applicable to both receiving and in-process inspection processes.
- Escalates all issues to a higher level of management when no response or support is provided.

Nonconformity Management:

- Ensure DMS (Discrepant Material Storage) activities are processed in accordance with procedures and in the most efficient manner possible. Note: This includes all DMS locations within the MEC organization.
- Ensures all suspect non-conforming (SNC) material is properly identified IAW procedures.
- With the Department's goals in mind, the processing of SNCs must be managed and prioritized by the internal need date.
- Escalates all issues to a higher level of management when no response or support is provided.

SKILLS / REQUIREMENTS

- Minimum of 5 years of supply chain management or supplier quality management experience.
- Minimum of 3 years in the processing of aerospace and defense hardware (HW) quality control.
- Minimum of 8 years in a hands-on supervisory or management level experience.
- Minimum of 3 years of working directly with DCMA.

JOB OPPORTUNITY

- Subject matter expert in all areas of Quality Control.
- Ability to read and interpret drawing and specification requirements.
- Must be able to create and present metrics to support quality status and goals.
- Must have excellent and effective communication skills, verbal and written.
- Must have excellent writing (English) skills and be able to write procedures and work instructions.
- Must have experience with Material Review Boards and the Causal Analyses and Resolution process.
- Must have excellent team building skills; collaborative problem solver; and can work effectively with all levels of personnel.
- Understanding of the AS9100 SAE standard and the aerospace quality system requirements, preferred.
- College degree in Business Management, Engineering or related field.
- Proficient in the use of Microsoft Office applications (MS Word, MS Excel, MS PowerPoint).
- ASQ or equivalent certification preferred.
- Must be able to speak/read/write English.
- Must be able to lift up to 35 lbs.
